Please read ALL the information below carefully, as some of the information has changed.
Our COVID regulations are based on the current Ontario Stage 3 protocols.

REQUIRED FOR TOUR ENTRY:

1. **YOUR PURCHASED TICKET. Present mobile or printed version with QR code.**

2. **A FACE MASK.** Attendees aged two years and older are required to always wear face coverings while in the homes. Face coverings must be made with at least two layers of breathable material and fully cover the nose and mouth and secure under the chin and against the sides of the face.

3. **PROOF OF FULL COVID-19 VACCINATION – Present mobile or printed version:** the full series of a World Health Organization approved COVID-19 vaccine or combination of approved vaccines, received at least 14 days prior to the event.

Ontario residents need to visit <https://covid-19.ontario.ca/proof-covid-19-vaccination>, and enter your health card number.

3a. If you **CANNOT VACCINATE DUE TO HEALTH REASONS**, you will need proof of a **NEGATIVE COVID-19 TEST** result from a healthcare provider taken within 48 hours of the event's scheduled start time. Email us if you have concerns.

4. **PHOTO IDENTIFICATION (HEALTH CARD, DRIVER'S LICENSE)**

5. **A SCREENING QUESTIONNAIRE will be self-administered on-site.**

6. **ALL CHILDREN UNDER THE AGE OF 12** must be within arm's length of, and always attended to by their parent or guardian.

7. **RECEIVE YOUR WRISTBAND FOR THE DAY TOUR at any of the 7 homes (there is no specific order).** Keep your wristband if you wish to return on Saturday for the General Day Tour, and for visits to annual sites and complimentary wine tastings.

8. At **McARTHUR ENCHANTED WONDERLAND**, you will receive a **STICKER** which can be used for entry to the annual sites and for complimentary wine tastings. **Keep your event ticket as well.**

Volunteers and attendees must follow the current Ontario Public Health regulations, including wearing a mask when indoors, hand hygiene, and observing physical distancing whenever possible. All volunteers and attendees must PASS the COVID-19 Screening Questionnaire on the day of the event.

The Holiday House Tour will be operating at limited capacity with a maximum of 100 people on the grounds of each location at a time and a maximum of 25 people within the homes at a time (including volunteers). Volunteers will be monitoring flow of attendees to ensure social distancing is maintained.

Attending any public space where people gather involves some risk of exposure to COVID-19. By attending the Rotary Club of Niagara-on-the-Lake events, you voluntarily assume all risks related to possible exposure to COVID-19.

If you are feeling unwell or have any of these symptoms: coughing, fever, or shortness of breath, DO NOT ATTEND.
